The Amanda and J. David Williams Surgery Center will serve as the primary outpatient surgery center and will expand Peterson Health's current capacity of surgical suites by 25% and procedure rooms by 50%.

The estimated cost of the new surgery center is \$38M with approximately half

of the funding provided by YOU, our generous donors. The new facility's projected completion date is Spring 2024.
